

Associations between Poverty and Disruptive Behaviors in Early Childhood: The Mediating Role of Maternal Depression and Parenting Practices

Introduction

- Poverty is a risk factor for children's mental health¹;
- Researchers have identified several mediators of poverty and disruptive behaviors²⁻⁴;
- Few studies have examined the association between poverty and disruptive behaviors in early childhood. Even less is known about potential mechanisms explaining this association.

Objectives

- 1 Examine whether poverty contributes to an excess risk of disruptive behaviors in early childhood – i.e. physical aggression and hyperactivity;
- 2 Identify whether parenting practices, family processes, and maternal depression explain the association between poverty and disruptive behaviors.

Study Design

- Québec Longitudinal Study of Child Development (1998-2010);
- A population-based birth cohort;
- N=2120 followed yearly from birth to 5 yrs.

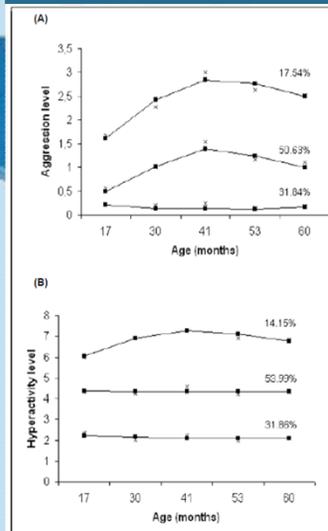
Main outcomes

- High trajectory of physical aggression;
- High trajectory of hyperactivity;
- 1½ -5yrs.

Exposure

- 3-4 episodes of household income below the federal poverty line ;
- 5mo-3½ yrs.

Result I : Trajectories



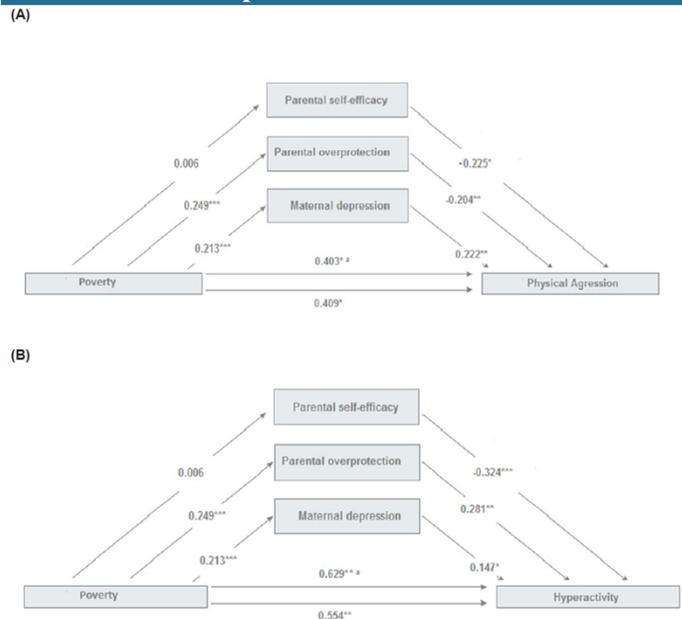
Analytical Strategy

- Semi-parametric mixture modeling to calculate physical aggression and hyperactive trajectories;
- Multivariate logistic regression to examine the contribution of poverty;
- Bivariate associations to select potential mediators (criteria of $p < .30$);
- Single-step multiple mediation model⁵ to identify indirect effects of family variables;
- Confounds: child's sex, maternal education, family structure, childcare service.

Result II : Poverty Predicting High Trajectories of Physical Aggression and Hyperactivity

Result III : Multiple Mediation Model

Conclusion

- Poverty heightens the likelihood of disruptive behaviors over the first 5 years of life and its contribution occurred partially through parenting practices and maternal depression.
- Developing policies and practices to address maternal depression, parenting, and poverty is one important avenue to improve children's mental health early in life.
